This cookie notice applies to all websites, services, messaging (e.g., email and online chat communication), and mobile-device applications that are operated by or on behalf of Asl.cudoo.com; and Asl.cudoo.com-branded pages on third party platforms (together “**Sites**”). This cookie notice describes how and where Asl.cudoo.com and its partners use cookies or similar technologies to: analyze trends; administer the Sites; track users’ digital properties and movements around the Sites; and gather information about the Asl.cudoo.com user base as a whole.

What is a Cookie?

A “cookie” is a small text file that a website saves on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or to work more efficiently, as well as to provide reporting information.

Cookies set by Asl.cudoo.com are called “first party cookies”. Cookies set by parties other than Asl.cudoo.com are called “third party cookies”. Third party cookies frequently enable certain third-party features or functionality to be provided on or through websites or services such as advertising, analytics, and interactive content.

When Asl.cudoo.com uses cookies, web beacons and similar technologies

Cookies: Asl.cudoo.com uses cookies to collect information about your device, such as IP address, operating system and browser type. The types of cookies that we use are detailed below:

- **Required.** These cookies, also known as “Strictly Necessary” or “Essential”, help you to move around the Sites. For example, if you are required to sign into a Asl.cudoo.com powered Site, the cookies identify you as being signed in and remember you so that you do not have to sign back in every time you move between the Sites.
- **Functional.** Asl.cudoo.com uses these cookies so that the Sites recall the choices you make. For example, these cookies are capable of recognizing if you have been to one of the Sites before, so messages intended for first-time users are not displayed to you. Asl.cudoo.com may also use functional cookies to tailor content or advertisements to match your preferred interest and to avoid showing you the same advertisements repeatedly.
- **Advertising.** These cookies are used to make advertising messages more relevant to you. They perform functions like preventing the same ad from continuously appearing, ensuring that ads are properly displayed for advertisers and in some cases selecting advertisements that are based on your interests.
- **Analytical.** These cookies help Asl.cudoo.com identify the number of unique visitors to the Sites, whether or not those visitors are repeat visitors, and the source of Site traffic. For example, if there are 1,000 visits to a Site on a certain day, Asl.cudoo.com can use cookies to discover how many of those visits were made via the same browser (same visitor). Asl.cudoo.com may also use the

cookie to discover whether you have visited Asl.cudoo.com Sites more than once, and the source for each visit. Cookies help Asl.cudoo.com to compile anonymous, aggregated statistics so that Asl.cudoo.com can: better understand how people use the Sites; improve the structure of the Sites; and count the number of anonymous users of the Sites.

- **Session cookies.** These cookies allow us to link your actions during a particular browser session.
- **Persistent cookies.** These cookies allow us to recall your preferences or actions across multiple Sites.

In addition to the reasons for our use of cookies detailed above, Asl.cudoo.com uses the information gathered from cookies (namely, IP addresses) to help diagnose problems with Asl.cudoo.com servers and to administer our Sites.

Web Beacons. Asl.cudoo.com uses web beacons to track your movements to, from and on the Sites to determine the effectiveness of content and advertising campaigns, particularly as they enable Asl.cudoo.com to count the number of times that Asl.cudoo.com advertisements and web-based email content are viewed.

Server logs. If you arrive at a Site by clicking on an advertisement that Asl.cudoo.com has paid for (including a paid search engine result), or a link in an email sent from or on behalf of Asl.cudoo.com, then Asl.cudoo.com will capture information that tracks your visit from that link (e.g., referring URL, browser information). If you arrive at a Site by clicking a source not paid for by Asl.cudoo.com, such as link in a non-paid search engine result or an unsponsored link on a third party's website, Asl.cudoo.com may capture information that tracks your visit from that source, to the extent Asl.cudoo.com is able to do so. Asl.cudoo.com may also capture information about your computer system, such as your browser type and operating system. Asl.cudoo.com may also gather certain information automatically, such as Internet protocol (IP) addresses, Internet service provider (ISP), the files viewed on a Asl.cudoo.com Site (e.g., HTML pages, graphics, etc.), operating system, date/time stamp, and/or clickstream data to analyze trends in the aggregate and administer the site.

Asl.cudoo.com Sharing Tools. Asl.cudoo.com would like to draw your attention to the fact that the Asl.cudoo.com Sites carry embedded "share" and "like" buttons to enable visitors to Asl.cudoo.com Sites to share content through a number of social media networks. These networks may set a cookie when you are logged in to their service. Asl.cudoo.com does not control the dissemination of these cookies and you should check the relevant third-party website for more information about these cookies.

Cookies set by third parties on third party sites

To enhance your experience of Asl.cudoo.com powered Sites, we sometimes embed photos and video content that originated from third party websites (such as YouTube etc). As a result, when you visit a page on a Asl.cudoo.com Site that features content from, for example, YouTube or other such services, you may be presented with cookies from these websites. Asl.cudoo.com does not control the dissemination of these cookies. You should check the relevant third party's website for more information about these cookies.

How to control and delete cookies

You have the right to decide whether to accept or reject cookies (apart from those that are required or essential). You can exercise your preferences in relation to cookies served on our Sites by using the Asl.cudoo.com cookie consent tool.

You can also use your browser to reject all, or certain, technologies. However, if you use your browser settings to block all such technologies, you may not be able to access all or parts of the Sites. Turning cookies off, for instance, will prevent you from registering for, signing in to, and using many of the services on those Sites.

If you want to control the cookies that are placed on your computer or other device, you could:

- view cookies stored on your hard drive;
- choose whether or not to permit cookies to be set by default; or
- delete the cookies stored on your hard drive.

The main browsers allow you to change your cookie settings. These settings will typically be found in the 'options' or 'preferences' menu of your browser. You may also use the 'help' option in your browser for more details. If you are visiting this site using a mobile device such as a smartphone or tablet, please refer to the manufacturer's instructions on how to manage cookies.

To fully ensure that no cookies or other technologies are used when you visit the Sites, you also have the option to refrain from using Sites.
